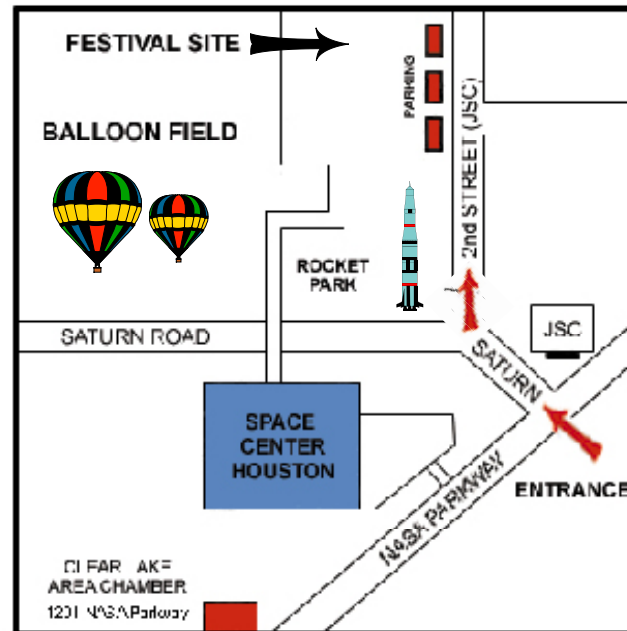

2009 VENDOR GUIDELINES

Friday, Saturday & Sunday

October 23 -
October 25



The 2009 RE/MAX® Ballunar Liftoff Festival will feature hot air balloon competitions, evening balloon glows, skydiving exhibitions, commercial exhibits, concession booths, arts & crafts exhibits, entertainment and various aviation equipment displays. Starting on Friday, October 23 through Sunday, October 25, Johnson Space Center will be transformed into the RE/MAX® Ballunar Liftoff Festival site. Johnson Space Center is located off NASA Parkway at Saturn Road in the Clear Lake Area, between Houston and Galveston, Texas.

VENDORS

Rules and Regulations: NEW exhibitors must submit 3 photos of items. The Vendor(s) must be present during the festival.

No pets will be allowed on festival grounds.

Festival Times: Exhibitors are to remain open for business during all festival hours starting Friday evening.

Friday, October 23	6 pm - 10 pm
Saturday, October 24	6:30 am - 10 pm
Sunday, October 25	6:30 am - Noon

Set-Up:

1. A Parking Permit will be mailed to approved exhibitors prior to the festival. All vendors will receive credentials (wristbands) upon arrival at set-up.
2. Set-up begins at 8 am and MUST be completed by 5 pm Friday.
3. All vehicles MUST be out of the festival area

Exhibitor Parking: The exhibitor parking area is available to badged exhibitors ONLY, at no charge.

Lighting & Electricity: Only one (1) 20 amp circuitry with 110 plug for a fan and booth lighting is pro-

Clean-up: All exhibitors are required to leave their spaces clean and undamaged at the end of the festival. No booth will be disassembled until the close of the festival and the public has left the area.

Sales Tax: Exhibitors are responsible for collecting and reporting their own sales tax.

Registration Deadline: Application and fee MUST be received by the Festival no later than Friday, October 10th. Late applications will be accepted on a stand-by basis with an additional fee of \$25. Only money orders, cashiers checks or cash will be accepted after October 10. Any refunds prior to that MUST be requested in writing. There will be a \$10 service charge deducted from any refunds. There will be a \$20 service charge on any checks

returned due to insufficient funds. Refunds will not be given to "no shows." There will be no refunds for rain; and no rain dates

Display: Vendors must provide their own tents, displays, tables, chairs and back walls. Keep excess merchandise out of open view (in boxes under tables or in vehicles.)

Tent Tie-Down: All vendors must secure their tents, awnings and other display items against the wind. All upright poles and tie-downs must each be secured with at least 25 lbs. Exhibitors are responsible for any damage caused by their items to other exhibitors' merchandise and/or to the customers. DO NOT damage the grounds in any way.

Food: There will be NO UNAUTHORIZED FOOD OR BEVERAGE SALES.

Security: Security will be provided by Johnson Space Center. You may leave your tents and awnings up and your display items on site. Ballunar Liftoff Festival, Inc., CLACC, SCH and NASA/JSC will not be responsible if anything is lost or stolen.
